Lawn Care/Snow Removal - Mike Ganz, Settlement Hill

- Settlement Hill conducted a neighborhood walk-through the week of October 30th
- A list of dead shrubs was compiled
- Goal: Create a reasonable schedule for shrub replacement to bring uniformity to the community
- Shrub pruning was completed early spring will bring new growth
- Pet Owner Reminder: Pick up pet waste notices and fines will be issued for noncompliance
- A suggestion was made to consider drought resistant shrubs when replacing

Insurance - John Volgren, Farmers Insurance

- Review of Management Report
- BuildTec will return in late spring to begin work on roof replacement phase III (notices will be sent two weeks prior)
- Kinwood completed a reserve study in 2017 which assists in long-term planning
- The Association is on track to meet all 2017 financial obligations
- Emergency funds need to be built back
- Annual 5% Association dues increases will continue through the roofing project to build a healthy reserve
- Tree trimming will take place in the coming weeks Save-A-Tree

Financials - Chad Nieland

- Chad recently reviewed the 2017 budget with Kingwood Management
- Positive changes have been made, saving the Association \$40,000+
- The budget is stronger than it has been in recent years
- Collection of unpaid dues has gone from \$30,000 to no significantly delinquent accounts
- Chad created a collection process that Kingwood now follows

2018

- The Board is focused on getting an early spring start to 2018 improvements
- Kingwood will request a bid for a power-washing service to clean all building exteriors of mold/mildew
